The contractor shall provide a quarterly administrative fee of 1.5% to the State of Alaska. The contractor shall submit a check, payable to the State of Alaska, Department of Administration, Division of General Services for the calculated amount equal to 1.5% of all contract sales (minus all applicable contract discounts, rebates, credits or value added incentives, excluding sales, use or other applicable taxes, surcharges, or like fees) for the quarterly period.

The contractor must include the PA Number on the check. Checks submitted to the state without the PA Number will be returned to the contractor for the required information.

Administrative fee checks shall be submitted to:

The administrative fee shall not be included as an adjustment to the contractor's Master Agreement pricing and shall not be invoiced or charged to an ordering agency.

Administrative fee checks are due for each quarter as follows:

State Fiscal Quarter 1 (Jul 1 - Sept 30):	Nov 30
State Fiscal Quarter 2 (Oct 1 - Dec 31):	Feb 28
State Fiscal Quarter 3 (Jan 1 - Mar 31):	May 31
State Fiscal Quarter 4 (Apr 1 - Jun 30):	August 31

Any quarter with zero sales must be reported as zero sales. This may be done electronically via email to the State of Alaska contact listed in this PA or their successor(s).

2. Volume/Usage Reports:

The contractor must provide a quarterly volume report to the DGS contracting officer (Participating Entity contact or their successors), whichever is requested by the contracting officer. The report must include information which allows the contracting officer to determine the amount of savings realized under the contract and to verify the administrative fee payments align with the reported contract spend.
