Cisco announces the end-of-sale and end-of-life dates for the Cisco Meeting Server 1000 M5. The last day to order the affected product(s) is August 30, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

The CMS 1000 M5 was based upon Intel chipsets that have been superseded. Therefore, the CMS 1000 M5 is being superseded by the CMS 1000 M5 v2 (CTI-CMS1KM52BUN-K9).

End-of-Life Announcement Date	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	March 1, 2021
End-of-Sale Date: HW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	August 30, 2021
Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	November 28, 2021
