#### Overview

#### **EOL13771**

Cisco announces the end-of-sale and end-of-life dates for the Cisco Meeting Server 2000 M5. The last day to order the affected product(s) is August 30, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

The CMS 2000 M5 was based upon Intel chipsets that have been superseded. Therefore, the CMS 2000 M5 is being superseded by the CMS 2000 M5 v2 (CTI-CMS2KM52BUN-K9).

End-of-Life Announcement Date	The date the document that announces the end of sale and end of life of a product is distributed to the general public.	March 1, 2021
End-of-Sale Date: HW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	August 30, 2021
Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	November 28, 2021
End of Vulnerability/Security Support: HW	The last date that Cisco Engineering may release a planned maintenance release or scheduled software remedy for a security vulnerability issue.	August 29, 2024
End of Routine Failure Analysis Date: HW	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	August 30, 2022

Last Date of Support: HW	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	August 31, 2026
