

# Cisco Announces the End-of-Life and End-of-Support Dates for Cisco HyperFlex Data Platform Software Release 4.5(2x)

## Cisco announces the end-of-life and end of support dates for Cisco HX Data Platform Software Versions 4.5(2x).

Software maintenance support for 4.5(2x) software release will end on December 17, 2022. No bug fixes, patches or maintenance releases will be provided for this Cisco HyperFlex Data Platform release after that date. The last date of support for Cisco HX Data Platform Software Version 4.5(2x) is December 31, 2023.

Starting from December 17, 2022, only sev1 and security vulnerability issues will be addressed with HX Data Platform releases 4.5(2x). It may be necessary to upgrade to later software release to correct a reported problem.

Software maintenance requires an active service contract.

### Product migration options

Customers currently running HyperFlex Data Platform version 4.5(2x) should upgrade by December 31, 2023 to the latest Recommended Release. Cisco HyperFlex Data Platform's Software Download page to get the latest Recommended Release can be found here:
