End of SW Maintenance Releases Date: OS SW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software. The milestone applies to Standard Maintenance Release (SMR) rebuild.	October 10, 2015
	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software. The milestone applies to the Extended Maintenance Release (EMR) rebuild.	October 10, 2016
End of Vulnerability/Security Support: OS SW	The last date that Cisco Engineering may release bug fixes for Vulnerability or Security issues for IOS XR 4.3. After this date, bug fixes for Vulnerability or Security issues identified in IOS XR 4.3 may be provided through later supported software releases. Note that there will be no rebuild releases of IOS XR 4.3 provided after this End of Vulnerability/Security Support milestone date.	October 10, 2017
Last Date of Support	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	April 30, 2020
