Cisco announces a change in product part numbers for the Cisco ISR 800 IOS Software AX Technology Package Licenses. This is a product part number change only announcement. The last day to order the affected product using the current product part numbers is July 16, 2014. Customers will continue to receive support from the Cisco Technical Assistance Center (TAC) until otherwise specified in the end-of-life announcement for the new product part numbers.
