Cisco announces the end-of-sale and end-of life dates for the Cisco ASR 9000 400-Gbps IPoDWDM Line Card. The last day to order the affected product(s) is June 17, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
