End of Vulnerability/Security Support: OS SW	The last date that Cisco Engineering may release bug fixes for Vulnerability or Security issues for IOSXE XE 3.12. After this date, bug fixes for Vulnerability or Security issues identified in IOSXE XE 3.12 may be provided through later supported software releases. Note that there will be no rebuild releases of IOSXE XE 3.12 provided after this End of Vulnerability/Security Support milestone date.	September 28, 2016
Last Date of Support	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	September 30, 2019
