## Overview

### EOL13826 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Cisco One Stealthwatch. The last day to order the affected product(s) is May 1, 2021. The last day to renew or add to an existing subscription is May 1, 2021. Customers with active service contracts and subscriptions (as applicable) will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. <b>End-of-Sale Date*</b>	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	May 1, 2021
<b>End of Change/Renewal Date*: Subscription</b>	The last date to Renew or Add to an existing subscription.	May 1, 2021
<b>Last Date of Support**: Subscription</b>	The last date to receive applicable subscription entitlements, service and support for the product as entitled by active subscriptions and service contracts (as applicable) or by warranty terms and conditions. After this date, all subscription and support services for the product are unavailable, and the product becomes obsolete.	May 31, 2024
