### EOL14997

Cisco announces the End-of-sale and End-of-life dates for the Cisco Catalyst 4000 Series Switches. The last day to order the affected product(s) is September 5, 2023. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

| <b>End of SW Maintenance Releases Date: App SW</b>  | The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.   | September 4, 2024  |

| <b>End of Service Contract Renewal Date: App SW</b> | The last date to extend or renew a service contract for the product.  | September 4, 2025  |
| <b>Last Date of Support: App SW</b>                 | The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete. | September 30, 2025 |
