Last Ship Date: OS SW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	July 5, 2016
End of SW Maintenance Releases Date: OS SW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes for IOS 15.1(2)SG and IOS XE 3.4.0SG. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software. The only exception is Vulnerability/Security issues that will be addressed as shown in the End of Vulnerability/Security Support milestone below.	January 4, 2017
End of Vulnerability/Security Support: OS SW	The last date that Cisco Engineering may release bug fixes for Vulnerability or Security issues for IOS 15.1(2)SG and IOS XE 3.4.0SG. After this date, bug fixes for Vulnerability or Security issues identified in IOS 15.1(2)SG and IOS XE 3.4.0SG may be provided through later supported software releases. Note that there will be no rebuild releases of IOS 15.1(2)SG and IOS XE 3.4.0SG provided after this End of Vulnerability/Security Support milestone date.	July 5, 2017
Last Date of Support: OS SW	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	July 31, 2021
