Cisco announces the end-of-sale and end-of-life dates for the Cisco Nexus 3000/9000 Releases 7.0(3)I2(x) and 7.0(3)I3(1). The last day to order the affected product(s) is March 1, 2019. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
