Cisco announces the end-of-sale and end-of life dates for the Cisco Nexus 9500 Classic 32-port 100-Gigabit Ethernet Line Card - N9K-X9432C-S. The last day to order the affected product(s) is August 24, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
