#### Overview

#### EOL13471 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Cisco Business Edition 6000M (M5) and 6000H (M5) Appliances. The last day to order the affected product(s) is March 2, 2023. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

BE6M-M5-K9 appliances may migrate to BE6K-M6-K9 appliances. BE6M-M5-XU appliances may migrate to BE6K-M6-XU appliances. There is no direct replacement for BE6H-M5-K9 or BE6H-M5-XU. Depending on application deployment model, a single BE6000H M5 appliance can migrate to either a single BE7000M M6 appliance (BE7M-M6-K9 / -XU), or to a pair of BE6000M M6 appliances (quantity 2 of BE6K-M6-K9 / -XU). If any existing embedded virtualization offer is in use, please note all offers have entered end-of-life and should be replaced with a commercial offer that has future support. For BE6K-VIRTBAS-7X, BE6/7K-VIRTBASP-7X, BE6/7K-VIRTENH-7X, please see bulletin EOL13629 for more details. For VMW-VS6-HYPPLS-K9, VMW-VS6-FND-K9, VMW-VS6-CVSTD-K9, please see bulletin EOL13450 for more details.
